THROUGH A CONTRACT WITH LANE COUNTY, WE SERVE ELIGIBLE FAMILIES IN LANE COUNTY. OUR FAMILY SUPPORT WORKERS PROVIDE PARENTING EDUCATION AND SUPPORT, MODEL APPROPRIATE INTERACTIONS, PERFORM DEVELOPMENTAL SCREENINGS, PROVIDE REFERRALS TO RESOURCES, AND HELP PARENTS IDENTIFY AND MEET GOALS. WE ARE CERTIFIED BY HEALTHY FAMILIES AMERICA. THE HEALTHY FAMILIES PROGRAM PROVIDED HOME VISITING SERVICES TO 168 FAMILIES FOR A TOTAL OF 504 PARENTS AND CHILDREN AND ASSISTED ADDITIONAL FAMILIES WITH SCREENING, RESOURCES, AND REFERRALS DURING THE 2022-2023 PROGRAM YEAR.
